It is very pleasing to see that the newer institutions that are involved with ACMA are now starting to reach maturity. This is indicative of a positive feeling throughout the ACMA community.

<u>Treasurers Report</u> as at 30/6/2006 Achievements for the past financial year:

1) The provision of seeding funds to the ACMC2006 conference organizers proved very useful to assist them in the initial

- start-up organization phase of the conference. This should now become a regular annual provision for future conference organizers, if the need arises. As it has happened for ACMA2006, these seeding funds have already been reimbursed back into ACMA bank account,
- 2) New ACMA account signatories were organised for the newly appointed ACMA executive committee, following the AGM at ACMC2005. Having two signatories at one location (Monash University – Peter & me) has certainly turned out to be an advantage!
- 3) The trial involving providing funding for ACMA2005 conference directly from the ACMA bank account was a complete success. All conference registrations and expenses were made through the ACMA bank account. This had the added benefit, that once the conference was over and all remaining bills paid, the conference membership dues were automatically be available in the ACMA bank account.

The final balance of the ACMA CBA Cheque account (3238 1007 3400) is \$5363.85. A full transaction schedule for the previous 12 months is available on line via CBA NetBank. With ACMA membership dues from ACMA2006 anticipated to be somewhere in the vicinity of \$700-1300, this should raise ACMA'a account balance to well over \$6000. Members may be interested to know that CBA now charges a minimum \$5 per month account service fee, amounting to \$60 per year. If this is deemed to be unacceptable, then we may want to look at what alternative bank account options are available.

Once the new executive committee has been finalised at this year's AGM, new account signatories will again be organized, if required.

This will be reciprocated with a concert of curated US composers to be performed in Australia. The Sydney Conservatorium of Music has confirmed their interest in hosting the concert of US composers.
